Dog Reminder

Vehicle Storage

A reminder that vehicles (including RV's) are not allowed to be stored on the street for more than 72 hours. Any vehicle parked longer than the allowed 72 hours is in violation of City Ordinance.

Utility Bills

If you are only making a partial payment to your bill, you must first contact City Hall at 503-769-5475. If your monthly water/sewer bill is not paid in full by the 20th of the month, you will incur a \$25.00 late fee.
